With reference to the findings from the study titled "Multi-Level Exploration of Barriers and Enablers in Type 1 Diabetes Care in Karnataka" conducted by Veruschka et.al in collaboration with MS Ramaiah Medical College, supported by the Karnataka Institute of Endocrinology and Research (KIER) and the Department of Health & Family Welfare, the Government of Karnataka recognizes the urgent need to strengthen Type 1 Diabetes Mellitus (T1DM) care services across the state.

The Key challenges identified include:

- Expensive and irregular insulin supply
- Limited access to regular glucose monitoring, especially HbA1c testing
- Financial, psychosocial and mental health burden on patients and caregivers
- Gaps in medical education and healthcare provider capacity building
- Gender-related barriers impacting access to care

In this regard, it is proposed for the constitution of a State Level Technical Advisory Committee to strengthen the T1DM care in Karnataka.

## Responsibilities

- Provide overall strategic direction and leadership for planning and implementation of T1DM interventions.
- Ensure alignment of proposed interventions with NHM objectives and obtain necessary approvals.
- Facilitate inter-departmental coordination for effective implementation.
- Recommend protocols for insulin therapy, glucose monitoring and complication prevention.
- Ensure availability and distribution of essential insulins across all districts.
- Strengthen T1DM screening, follow-up and referral services at Health & Wellness Centres.
- Integrate T1DM screening and management with RMNCH+A initiatives.
- Include T1DM screening under Rashtriya Bal Swasthya Karyakram (RBSK).
- Provide academic and research support for evidence-based recommendations.

The Committee shall meet periodically to review progress, deliberate on challenges and provide recommendations to the State NCD Division for strengthening T1DM care.
