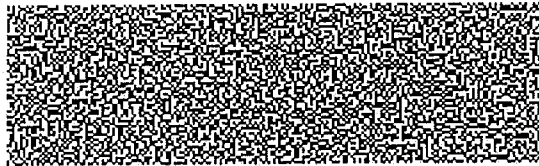
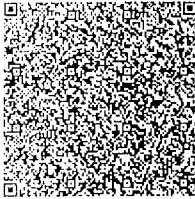

This Memorandum of Understanding (MoU) is made on this Eleventh day of July 2025, between the Department of School Education, Government of Karnataka, New Public Offices Premises, Nrupathunga Road, Bengaluru - 560001 (which term shall unless expressly excluded by or is repugnant to the context, shall include its successors and assigns) of the First Party;

PROJECT SURYA NAYAK (PSN), a non-profit movement founded by Ms. VERUSCHKA PANDEY (minor hence represented by Mrs. Anuja Pandey) having its Registered Office at # I-901, MANTRI ESPANA, Kariyammana Agrahara, Outer Ring Road, Bellandur, Bengaluru-560103, represented by Mrs. ANUJA PANDEY, (which term shall unless expressly excluded by or is repugnant to the context, shall include its successors and assigns) of the Second Party.

AND WHEREAS the First Party is an Education Department, which provides school education from 1st – 10th Standard throughout State of Karnataka and for the matters connected therewith.

AND WHEREAS the Second Party is a not for profit movement, started by Ms. Veruschka Pandey to create awareness and give life-saving first aid training on Cardio-Pulmonary Resuscitation (CPR) to revive and save people affected by stoppage of breathing / heartbeat.

AND WHEREAS the parties, through professional interactions and collaboration seek to bring in a holistic qualitative enhancement in first aid education in the Karnataka Public Schools, of Bengaluru North, Bengaluru South and Bengaluru Rural educational districts in Karnataka, enter into this MoU to establish a strategic partnership in the areas given in more details in the succeeding paragraphs.

Preamble and Objectives:

1. Lakhs of people die every year due to Sudden Cardiac Arrest in India. Nearly, 7 Lakh cases of sudden cardiac deaths occur annually, making it one of the leading reasons for death in our country. Nearly 40,000 such deaths happen in Karnataka State. Despite being prevalent, cardiac arrest goes undiagnosed as many people confuse it with heart attack. Further, 80% of cardiac arrests occur outside of hospitals, meaning that the chances of survival depend on immediate bystander's intervention (called "first responder"). However, only 2% of Indians are trained in CPR, compared to 18% in developed countries. The average ambulance response time in India is 15 – 30 minutes compared to 4 - 6 minutes needed to save a person under cardiac arrest. Under such a situation, there is a need to train students and community at large to prepare them for timely delivery of Cardiac First Aid in the form of Cardiopulmonary Resuscitation (CPR).
2. A proper CPR intervention can improve survival rates by 3 to 4 times, thus having the possibility of saving thousands of lives annually.
3. The objective of MoU is to create Awareness and to provide hands-on first aid CPR training to students in Classes 9th to 10th and the school staff as well. This will create a pool of trained first responders in the society.

4. Formation of First Aid Clubs in various schools (if these are not there) and providing them necessary materials for training.

Strategic Collaboration (Objectives, Scope & Outcome):

1. This MoU with the First Party will give more impetus to our outreach and awareness with the CSE approved Karnataka Public Schools (KPS), hence enabling more hands-on community services.
2. There is no monetary commitment from the First Party for this training and various Schools will approach Second Party, for conducting CPR Trainings in their Campuses. The training shall be conducted in 31 KPS schools located in Bengaluru North, Bengaluru South and Bengaluru rural districts, covering students class 9 to 10. The list of schools is annexed to this MoU.
3. The Second Party is having a tie-up with the State Institute of Health & Family Welfare (SIHFW) and Manipal Group of Hospitals. These institutions will provide necessary support in the form of emergency medicine trained doctors, Master Trainers, Mannequins and other related equipment to conduct the CPR Training.
4. Under PSN, it is planned to train about 1,00,000 students and community persons in the next 1 year with close coordination with SIHFW and Manipal Group of Hospitals throughout the State. Already PSN movement has trained around 10000 persons which includes ASHA workers, security personnel in Malls, bus driver and conductors, garment factory workers etc.
5. First & Second Party each will nominate Nodal Officer, whose responsibility will be to coordinate in conducting the CPR programmes in a smooth and effective manner without impacting the academic schedule of schools.
6. Each awareness and training session in the selected school will require 60 – 90 minutes and will train around 200-300 students and staff. It will consist of following activities:
 - (a) Audio-Visual and hard copies of presentation explaining necessity of CPR training and various facets and FAQs about CPR (15 – 20 minutes);
 - (b) Demonstration of CPR training by Doctors, Master Trainers and Volunteers of Project Surya Nayak (10-15 minutes);
 - (c) Hands-on training to all the participants in a group of 10 participants each with each participant learning and demonstrating the CPR technique. Each group will be given a Mannequin and a Master Trainer (25 – 35 minutes);

- (d) Question – Answer and clearance of doubts of trainees by Team Surya Nayak Project and formation of first aid club if it is not there by enrolling volunteers and providing basic first aid materials, if required (10-15 minutes);
 - (e) Each awareness-cum-training camp will be well documented (photos & videos) for better dissemination of information. Also, certificates of CPR training will be given to all participants who successfully complete and demonstrate the CPR training;
 - (f) The date and time for each training program will be decided by Nodal officers in consultation with the school principal. The First Party will provide necessary directions to principals of KPS for this through a letter.
 - (f) The First Aid Clubs in school can organize more training and PSN will facilitate for such training.
7. Regular classes/ teaching shall not be disturbed and safety of students during the training shall be ensured by the second party.
 8. Training sessions to be held only after the consent of the concerned school heads. No student shall be forced to participate in the programme.
 9. The training sessions for the year 2025-26 shall be completed by the end of November, 2025
 10. Advertising banners shall not be displayed in the school premises.

THE CSE AND THE PSN, UNDER THIS MOU, SHALL COLLABORATE TOWARDS:

Definitive Agreement: There will be no financial obligation on the part of the First Party for implementation of this MoU. Any cost associated with the execution of the objectives of this MoU, shall be solely and fully borne by the Second Party.

Term and Termination: The term of this MoU shall be for a period of TWO YEARS from the date of execution, unless terminated earlier by a written notice of thirty (30) days by any one of the Parties seeking such termination to the other Party, hereto. However, all commitments and obligations till the date of termination will be honoured by both the parties.

Neither party shall assign or transfer the privileges and obligations under this MoU without the prior written consent of the other party.

Governing Law: This MoU shall be governed by and shall be construed in accordance with the laws of India and the competent Courts in India shall have the exclusive interpretational, injunctive and supervisory jurisdiction over the disputes arising out of this MoU.



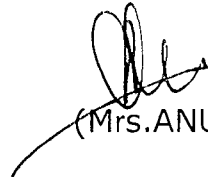
Dispute Resolution: Any dispute or difference arising out of or relating to or touching upon this MoU shall be amicably settled by discussion between the authorized representatives of Parties.
